Action Item 3	Ordinance #32-21 – 2021 Millage Rate
<p>Ordinance #32-21 of the governing authority of the City of Warner Robins.</p> <p>WHEREAS, Section 6.11 of the Warner Robins City Charter provides that the millage rate for City ad valorem taxes be set by adoption of an ordinance of the Mayor and Council.</p> <p>NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the City of Warner Robins that the millage rate for 2021 is set at 9.980 mills and the due date will be December 20, 2021.</p> <p>If any ordinance, or part thereof, of the City of Warner Robins is in conflict herewith, this ordinance shall have preference. If any provisions of this ordinance are held invalid, such invalidity shall not affect any of the other provisions which can be given effect without the invalid provision, and, to this end, the provisions of this ordinance are declared to be severable.</p>

<b>Second:</b>	Councilman Holmes
<b>Outcome:</b>	Councilmen Bibb, Lauritsen, Holmes and Lashley voted to approve. Councilman Mack and Curtis voted in opposition. Motion carries.
